Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. How?	All financial companies need to share members' personal information to run their everyday business. Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.  • Awakon Federal Credit Union has no affiliates.
Non-affiliates	Companies not related by common ownership or control.  They can be financial and nonfinancial companies.  • Awakon Federal Credit Union does not share with non-affiliates so they can market to you.
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.  • Investment companies  • Insurance companies  • Other financial service providers
