In a year full of unexpected ups and downs, Awakon is proud to have been able to adjust to the ever changing circumstances and offer financial aid to our members, where and when they have needed it.

Since mid-March, Awakon has responded to the Covid-19 Crisis in these ways:

- Members skipped 1,115 loan payments, with no fee attached (putting an extra \$279,542 back in the pockets of our members)
- Processed 83 PPP Small Business Loans for a total of \$2.2 million infused into our local communities
- In addition to offering Income Replacement Loans, we deferred auto loan payments and removed phone payment fees to assist our members further.
